## **Admission Criteria Fall 2018**

MIM Committee reviewed MIM admission criteria discussed and agreed on back in March of 2017.

- 1. New and only MIM admission deadline January 31, 2018
- 2. New MIM Targeted Essay Questions:
  - Why are you interested in the MIM degree at the University of Maryland
  - What do you see as the most significant opportunities and challenges in the information management field?
  - How do your interests and goals relate to the opportunities and challenges mentioned in the previous question?
  - What strength, abilities, and experiences will you contribute to the information management profession?

Reviewers look for applicant who:

- Demonstrate an understanding of the information management profession;
- Demonstrate characteristics of adaptability creativity, and collaboration;
- Are comfortable with or eager to learn new technologies;
- Have clearly communicated career goals and interests.
- 3. TOEFL required of at least 100

GRE/GMAT Requirement (if not waived) at least 40 percentile Verbal and 60 percentile Ouantitative

# Fall 2018 Application for Admission Update

An additional section was added to the application for admission, allowing application reviewers to read about applicants' strengths and achievements not only inside but also outside of the classroom. This will let application reviewers to better understand applicants' unique experiences, potential for success in the program, and prospective contributions to the graduate educational environment.
