- 2. Update: Fall 2017 Admissions (Carlea Holl-Jensen)
 - a. Admissions decision progress—HCIM admitted 90 students for Fall 2017; expected yield: about 27 enrolled students.
 - b. Carlea is revising the communications plan for admitted students
 - c. Takeaways for next admissions cycle
 - i. Streamlining use of Hobsons as a content repository
 - ii. Committee would like clearer documentation/guidelines for reviewers, including rubric for evaluating essays and portfolio
 - iii. More detailed data collection on applicant outcomes would be helpful
 - iv. From a holistic standpoint, "triaging" applications is important, but what is the return on that investment?
 - v. Essay requirement could be shortened significantly
 - vi. Applicants should indicate interest in research versus practical track
 - vii. Action Items:
 - 1. Carlea to share current guidelines and draft rubric
 - 2. Carlea to make small edits to application questions for next admissions cycle
 - d. Discussion: Program self-study
 - i. Building on Niklas's strategic plan for the program, as well as in-progress program development efforts
 - ii. Carlea is collecting data for the "longitudinal data" section, but committee should contribute to the "strategic overview" section.
 - iii. Self-study will be revised annually (will create a process to maintain document).

 - 1. Share Niklas' draft with committee, as well as original learning outcomes/program materials
 - 2. Committee will draft "strategic overview" section
- 3. HCIM Travel Award
 - a. Will be awarded to Pramod Chundury
 - b. In the future, committee would like to find funding to send students to practice-oriented conferences. And would also like to clarify that the award is about the level of participation, rather than research or practice
- 4. Update on program development/capstone
 - a. To be resumed in April committee meeting
